Festival representatives will direct vendors to their locations between 1:00PM-2:00PM. **VENDOR SET UP MUST BE COMPLETED BY 3:00PM ON FRIDAY**. *FOOD TRUCK VENDORS WILL BE GIVEN AN ASSIGNED SCHEDULE* 

An accepted application is commitment to the festival for both days and no refunds will be made after March 30th, 2017. Rejected applicants will be notified prior to April 15th. If rejected, your fee will be returned at this time. Note, your check will not be cashed until your application has been accepted by the festival organizers.

Each vendor will be provided with (2) wrist bands and (2) tasting glasses. Vendor staff are required to be 18+ years of age, and must be 21+ to receive a tasting glass and/or participate in any samplings.
