This event is held outdoors rain or shine and will operate from 12:00pm-6:00pm on September 9th. Vendor load-in will take place at 10:00am on the morning of. Generators or any other fuel/gas/burning equipment are not allowed inside. Festival representatives will direct vendors to their locations between 10:00AM-12:00PM. SET UP MUST BE COMPLETED BY 11:30AM.

An accepted application is commitment to the festival and no refunds will be made after August 28th, 2018. Rejected applicants will be notified prior to August 28th. If rejected, your fee will be returned at this time. Note, your check will not be cashed until your application has been accepted by the festival organizers.

Each vendor will be provided with (2) wrist bands to enjoy the waterpark for the day. Vendor staff are required to be 16+ years of age. Vendors are responsible for transport of their goods, tables, chairs, tents, etc.

Electricity is available on a limited basis, but must be requested on your application. Management reserves the right to deny electricity requests due to limited availability. Please include your electricity fee and space rental fee when returning your application. Vendors are responsible for collecting PA Sales Tax on sales made during the event.
