Festival representatives will direct vendors to their locations between 1:00PM-2:00PM. **VENDOR SET UP MUST BE COMPLETED BY 3:00PM ON FRIDAY. FOOD TRUCK VENDORS WILL BE GIVEN AN ASSIGNED SCHEDULE**

An accepted application is commitment to the festival for both days and no refunds will be made after March 30th, 2019. Rejected applicants will be notified prior to April 1st. If rejected, your fee will be returned at that time. Note, your check will not be cashed until your application has been accepted by the festival organizers.

Food Vendors will be asked to participate in our \$5 VIP Food Voucher program. Each VIP guest is given a \$5 Food Voucher good to use at ANY of our participating vendors, and Montage Mountain will pay back \$4 on every voucher redeemed at the end of the festival on Saturday to each participating food vendor. Please indicate participation.

Each vendor will be provided with (2) wrist bands and (2) tasting glasses. Vendor staff are required to be 18+ years of age, and must be 21+ to receive a tasting glass and/or participate in any samplings.

Electricity is available on a limited basis, and must be requested on your application. Management reserves the right to deny electricity requests due to limited availability. Please include your electricity fee and space rental fee when returning your application. Vendors are responsible for collecting PA Sales Tax on sales made during the festival.
