Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Montage Mountain Resorts, 1000 Montage Mountain Road, Scranton PA, 18507 ("Sponsor"), which shall be final and binding in all respects.
